By letter dated June 22, 2024, the New Jersey Division of Gaming Enforcement ("Division") requested the aforementioned company to complete and file a resubmission of information and documentation. The above-referenced resubmission was received and subsequently accepted for filing on November 21, 2024.

Please be advised that in accepting this resubmission, the Division is not taking a position on whether the abovementioned company is the only entity/qualifier that is required to file a license application in connection with the business being conducted with the Atlantic City casino industry. If the Division determines, after reviewing relevant information that additional licensure is required for other entities/qualifiers, you will be advised and those entities/persons will be required to file an application(s).

Furthermore, the CSIE license does not have an expiration date and will remain valid unless the company is informed otherwise. The Division will conduct an investigation based on the information and documentation provided in this resubmission. If there are no objections or concerns raised by the Division, the company's (Gaming) CSIE license will remain active and in good standing.

Lastly, all applicants are required to provide written notification within five (5) business days of any changes in the information reported within the resubmission, including changes in qualifiers and/or ownership. With respect to changes in ownership, please be advised that any such changes may affect the ability of the company to transact business with the Atlantic City casino industry.
